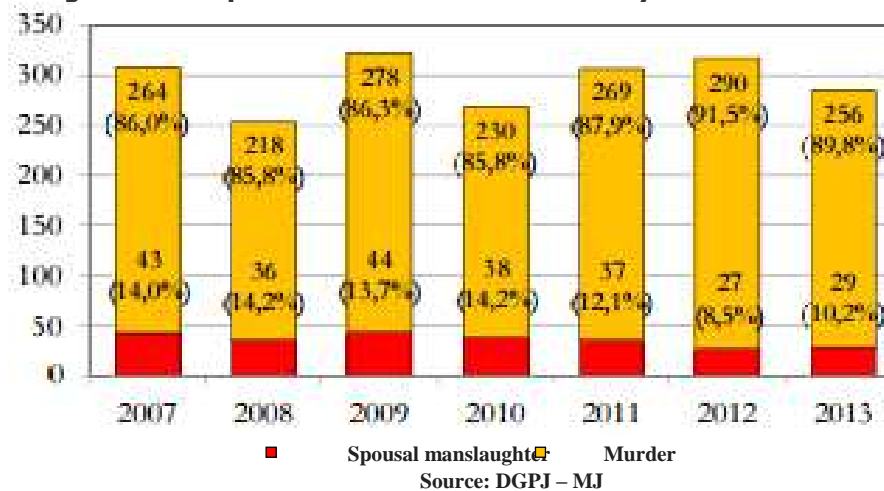

**Figure 1 - People convicted of murder in the years 2007 – 2013**



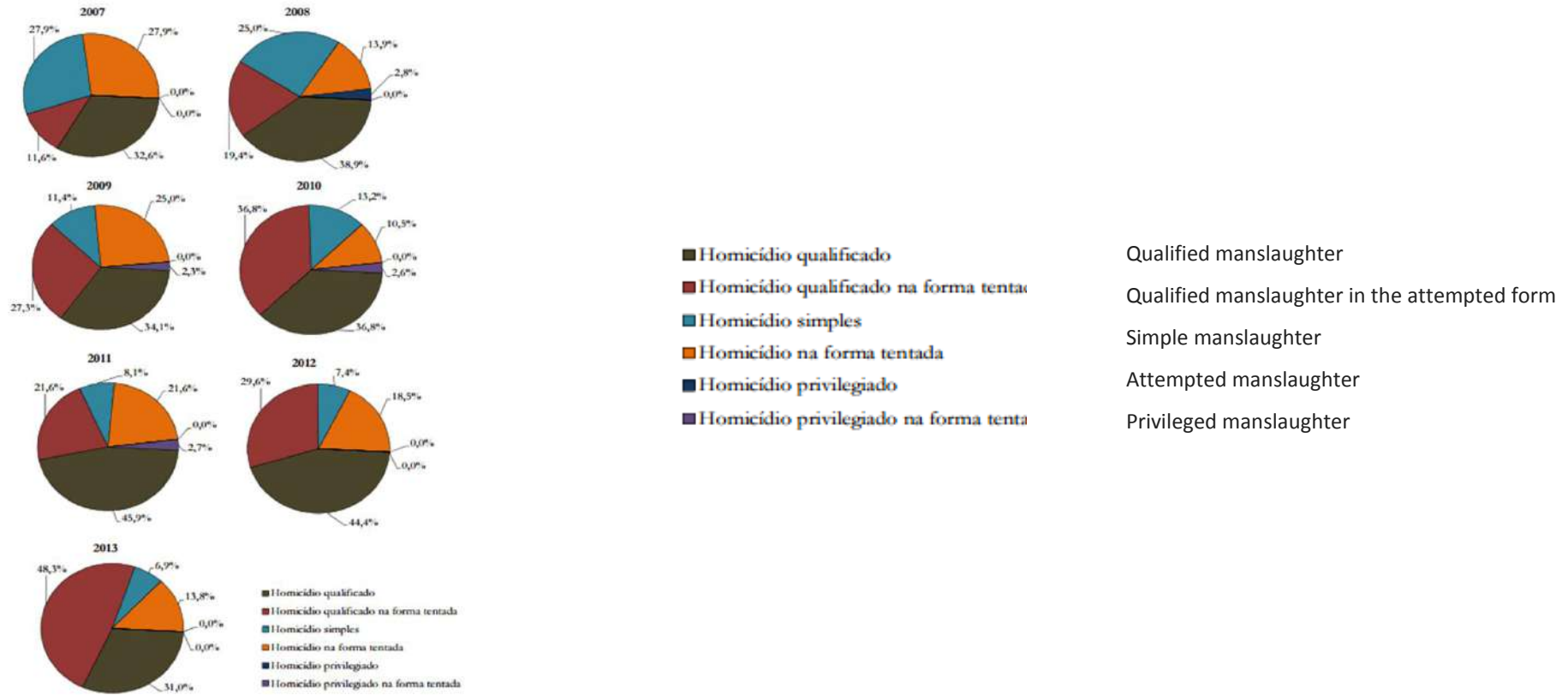

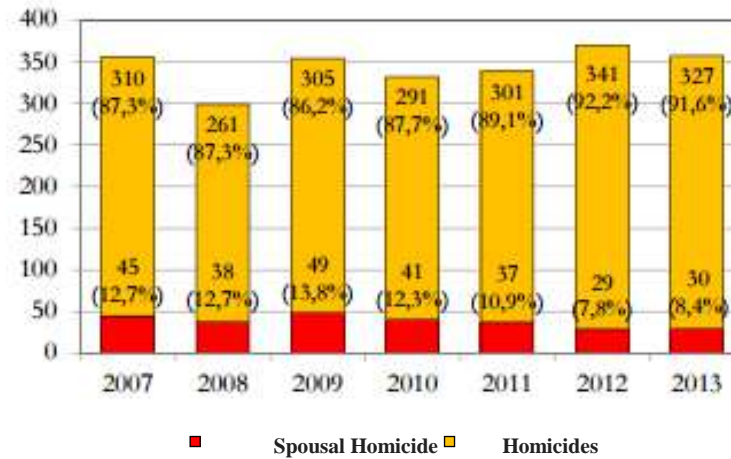
**Figure 3 - People convicted of spousal manslaughter by type of homicide in the years 2007 – 2013**

in the courts of 1st Instance (2007-2013)**

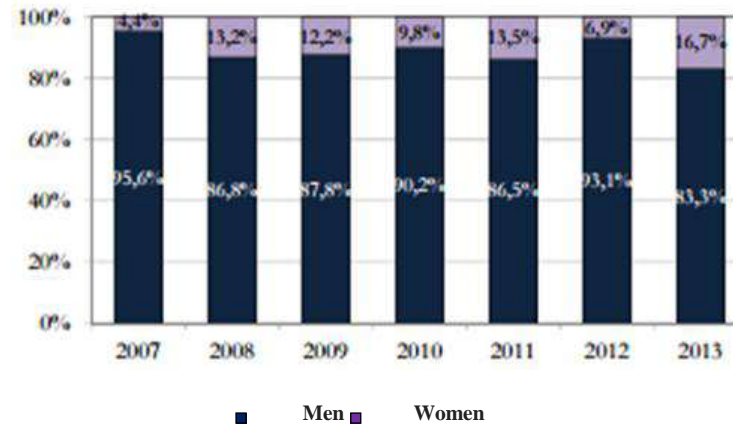
**Figure 4 - Convictions for murder in years 2007-2013**

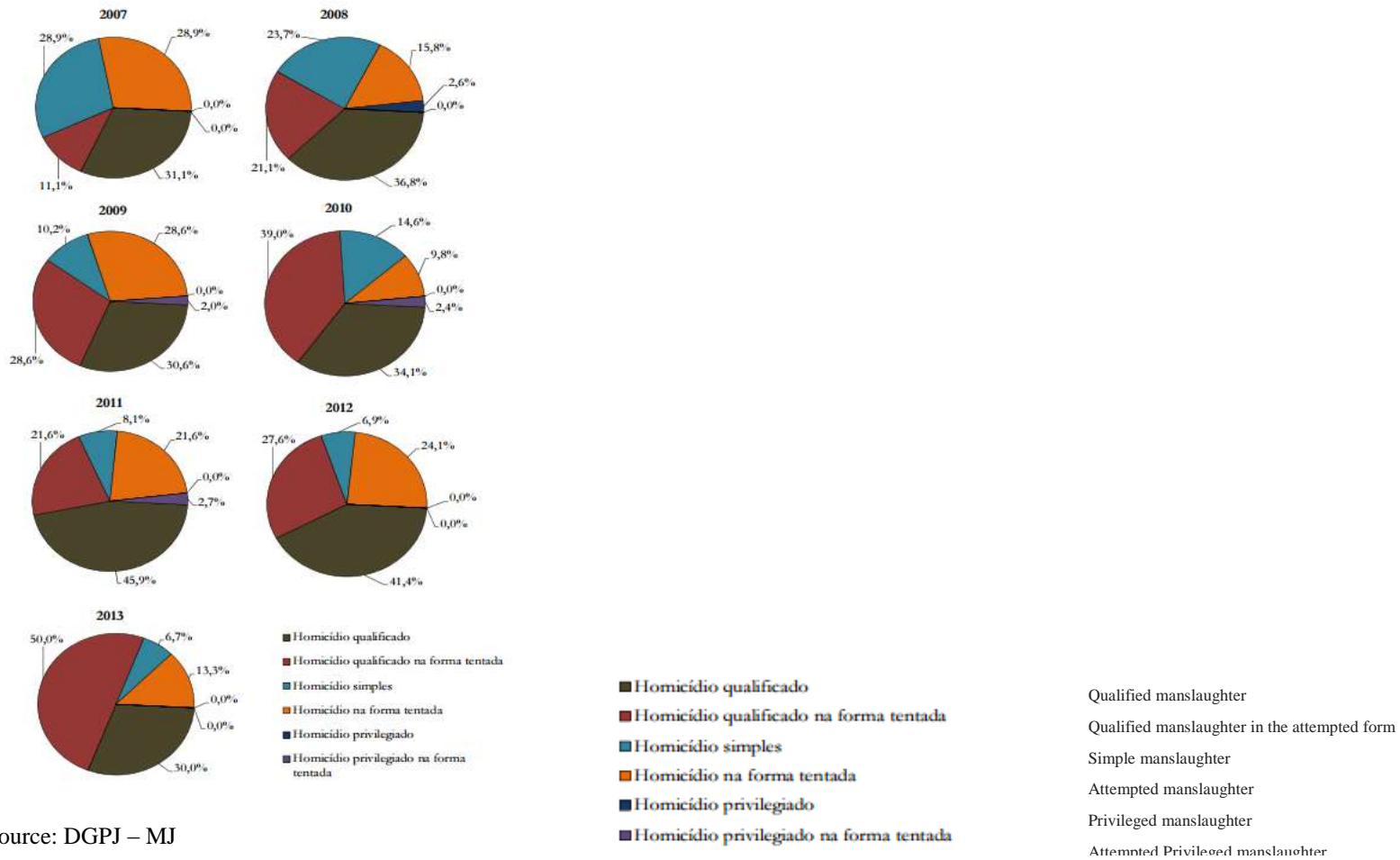
